Share-Net started as the Dutch network on sexual and reproductive health and rights (SRHR) and has been operational since early 2001. With support from the Dutch Ministry of Foreign Affairs, KIT Royal Tropical Institute initiated the network to respond to the needs of different international development stakeholders in the Netherlands to strengthen collaboration and increase the knowledge base to inform their work. Today, Share-Net International is the knowledge platform on SRHR. Share-Net International is a membership network of non-governmental organisations, researchers, policymakers, implementers, advocates, students, the media and companies operating in the SRHR field, working closely with a wide range of partners across the globe.

Share-Net International currently has 7 operational country hubs. The hub in the Netherlands was established in 2001. Hubs in Bangladesh and Burundi have been operational since 2014, the hub in Jordan since 2015. In 2021, Share-Net International set up the hubs in Burkina Faso, Colombia and Ethiopia and developed a Digital Platform.

In 2022, an external mid-term review assessed our progress towards our targets in the 2020-2024 funding cycle by the Dutch Ministry of Foreign Affairs and provided insight into our relevance, efficiency, effectivity, coherence and sustainability. Following the mid-term review, an update of the strategic plan has been undertaken.

OUR MISSION

To strengthen linkages between research, policy and practice through sharing, generating, translating and promoting the use of knowledge for the development of better policies and practices in SRHR.

OUR VISION

All people have the freedom of choice, are able to make informed decisions, can take action on their sexual and reproductive health and have access to quality care to meet their sexual and reproductive health needs and rights.


The <u>Theory of Change of Share-Net International</u> was drafted in 2018 in consultation with the hubs and members and has guided us since. It shows how the knowledge platform aims to achieve impact and outcomes across the four pathways of knowledge management. Additionally, it shows the importance of the development of the network itself in Communities of Practice (CoPs). The assumptions provide insights into the underlying thinking process of the logic. The current Theory of Change highlights that Share-Net International's knowledge management strategies contribute to the different outcomes through the following pathways:

- **Knowledge generation:** addressing priority knowledge gaps through research and further analysis and synthesis of existing data
- **Knowledge sharing:** dissemination through a wide range of channels and tools of both new and existing knowledge, as available research findings are often not known by those who should use them
- Knowledge translation: ensuring evidence is presented in formats appropriate for the intended audience so that they can be accessed, understood and used by advocates, policymakers, programme managers, practitioners, the private sector, users, the media and researchers
- Promotion of knowledge use: promotion of the use of knowledge products and formats by policymakers and practitioners for improving policy and practice
- Network development and matchmaking: creating Communities of Practice and links with partners, and matching the needs of certain members with the services that our partners can offer (e.g. between our members and the private sector and between young researchers and nongovernmental organisations in need of research)

In 2023, at the time of writing this plan, we have started a process to review the Theory of Change to reflect our evolved strategies and to prepare for the development of a new proposal in 2024.

This work plan is structured in three chapters:

- 1. Elaboration on our ambitions for organisational development (Chapter 2: Organisational Development)
- 2. The different network development and knowledge management outcomes (Chapter 3: Share-Net in 2024)
- 3. The plans for the revision of the Theory of Change and furute of the platform beyond 2024 (Chapter 4: Revision of Theory of Change and Future of Share-Net International)



STRATEGY 2023-2027

In January 2023 we launched our renewed Strategic Plan. The updated Strategic Plan builds on the recommendations from our Mid Term Review and reflects on key global trends in SRHR namely:

- growing opposition
- shrinking civic space
- the COVID-19 pandemic
- climate change

The importance of working on collective understanding of our values, from a **rights-based** and **intersectional feminist** perspective is highlighted, as well as the need to enhance Planning, Monitoring, Evaluation and Learning in order to evaluate the impact of our work which is critical to new strategic funding opportunities.

5 Strategies for the period 2023-2027 are being formulated around:

- 1. Strengthening financial sustainability
- 2. Advancing strategic partnerships
- 3. Enhance knowledge sharing and translation
- 4. Improving inclusivity
- 5. Developing membership engagement

These strategies have been incorporated in our work plan 2023 and will be continuously built on in 2024.

INTERNAL DEVELOPMENT

In 2024, Share-Net International celebrates its 10th birthday! Share-Net International has significantly grown in the past 2 years by setting up 3 new country hubs and a Digital Platform. Secretariats have grown in many ways. They have not only built and grown their country networks and started many new knowledge management projects (e.g. SHIRIM and Communities of Practice), but they have also increasingly engaged with each other (e.g. during the Co-Creation Conference and SHIRIM) and have started to explore regional activities. In 2023 we have focused more on national level activities, explored regional activities, and paid more attention to outcome measuring, which is important to secure sustainability. Throughout the year, we will take the opportunity to celebrate and share some of the greatest work done in earlier years. This will boost our visibility and strengthen our positioning beyond 2024.

Furthermore, in line with the recommendations in our mid-term review we will work on the following areas:

Focus on sustainability and fundraising

Financial sustainability and fundraising were already stipulated in the Share-Net Strategic Plan 2017-2022. Diversification of funds has been admired for a long period, particularly since the start of the current funding cycle (2020-2024). In 2021 and 2022, despite the challenges of the COVID-19 pandemic, ample efforts have been taken towards the development of a strategy. This was shared with the SNI board, country coordinators as well as in our annual planning.

In 2023 we managed to set-up a fundraising task force. The task force is led by the Share-Net International secretariat and represents all hubs. The objective of the task force is twofold:

- 1. To co-develop a sustainability plan including a partnership development and fundraising strategy and guide the development of country specific sustainability plans and partnership development and fundraising strategies.
- 2. To co-implement this plan together with all secretariats with the ultimate aim to strengthen and align fundraising efforts of and between the different secretariats.

Additionally, the task force will exchange and strengthen partnership development and fundraising capacity between the members.

During the last years of the current funding cycle by the Dutch Ministry of Foreign Affairs, we will take the execution of our sustainability plan as a top priority. Building on the already identified prioritised partners and donors, we will continue our fundraising efforts including reactive and proactive fundraising at all levels. Internationally through the Share-Net International Secretariat, as well as through the Share-Net hubs and regional activities.

Strengthening internal collaboration by focusing more on our core values

In the past years, Share-Net has taken its first steps towards better inclusion of young people and working on diversity and inclusivity. Having grown our organisation by increasing the number of staff and hubs, we now see the importance of continuing to work on the collective understanding of our values and work from a rights-based and intersectional feminist perspective as Share-Net.

In the coming two years, we will, therefore, continue to have in-depth conversations with all secretariats about our values and how these are operationalised in practice in the different countries. As a kick start to these in-depth conversations, we will be organizing a **joint learning trajectory to operationalize rights-based approach** throughout Share-Net activities. This will enable all Share-Net secretariats staff to enhance their knowledge and skills related to rights-based approaches with the aim of creating a shared language around SRHR and human rights as well as fostering a common understanding firmly rooted in the various different human right principles and how they relate to the Share-Net International work. The joint learning trajectory will include learning sessions and an assessment of SRHR policy and legal framework in the different country hub contexts using a rights-based intersectional lens.

As a minimum, all secretariats must be willing to move towards more progressive conceptions of sensitive SRHR topics, not only being able to move the movable middle among the Share-Net members towards more progressive ways of working, but also being able to support the more activist and progressive members.

Membership engagement

The development of membership engagement is a key strategy in our updated Strategic Plan. In 2023 a specific membership engagement strategy has been developed by the Share-Net International secretariat. Member engagement will not only take place in meetings but also online via country websites and social media as well as the different knowledge management activities led by the Share-Net International secretariat in collaboration with the country secretariats, such as Communities of Practice and the activation grants.

In 2024, Share-Net International would like to continue ensuring an equal representation of all the different stakeholders we aim to bring together (researchers, policymakers, and practitioners). This means that we will be reaching out to members that represent marginalised groups, or work in focus areas or on themes underrepresented.

With the support of the analysis tools within our Digital Platform and in our Customer Relationship Management system, as well as our Community Engagement officer and SRHR Content Developer, we will further develop and implement our membership engagement strategy.

Supportive Boards

The work of Share-Net International has always been overseen by an International Board, which provided strategic direction and programmatic oversight to Share-Net International in its capacity as a platform of the various country networks. Although conscious efforts to diversify the board, Dutch expertise still dominated the Share-Net International board. On the other hand, Share-Net International has become more and more international and grew in size. Discussions about dividing the rapidly growing Board started at the beginning of 2021. By the end of 2021 the entire Share-Net International board agreed to divide advisory and executive roles, but to stay together for the mid-term review and update of the Strategic Plan. The mid-term review did not recommend focussing on major changes in governance, however, the discussions on dividing the board had already been taken along in the review and were acknowledged as a positive development. Therefore, end of 2022 the Share-Net International Board agreed to divide into an Executive Board and an Advisory Board, each with a specific objective.

The Share-Net International Executive Board consists of representatives of the different host organisations and has joint responsibility for the overall execution and sustainability of the Knowledge Platform. **New to this mandate** is the joint responsibility for sustainability, which means that the board is expected to actively be involved in fundraising activities.

The Share-Net International Advisory Board is a diverse and inclusive board of recognized professionals, with a proven track record in SRHR research, policy and/or practice.

The Share-Net International Advisory Board has, with the Share-Net International Executive Board, the joint responsibility for the long-term strategic direction of Share-Net International and oversees agreed processes (Strategic Plan).

The Share-Net International Advisory Board also supports the efforts of the Share-Net International Executive Board to sustain Share-Net International.

In 2024 we will further position the role of the Executive Board and strategically attract new members to our Advisory Board.

EXTERNAL DEVELOPMENT

Link with the Dutch Ministry of Foreign Affairs and the Royal Netherlands Embassies

Our link with the Ministry of Foreign Affairs remains close and constructive. Different from the SRHR Partnerships, Share-Net is a long-term strategic partner. Share-Net functions as the knowledge broker between the 7 SRHR Partnerships in the Netherlands, as well as in the implementing countries, particularly those where we have Share-Net hubs. Relationships between our hub secretariats and these Royal Netherlands Embassies, are well established and supported by the Share-Net International Secretariat. Hubs are functioning as knowledge brokers between the in-country partners of the Dutch-funded SRHR partnerships as well as other key SRHR stakeholders. In 2024 we hope to further build on these relationships.

This is not only to:

- continue supporting knowledge management work to improve national level policy and practise
- broker knowledge between the partners within the Dutch funded SRHR partnerships

but also to:

- explore regional opportunities and activities, where possible, in collaboration with regional organisations and networks
- connect us with like minded donors

We hope to explore the possibility of jointly visiting a like minded donor with the Ministry of Foreign Affairs in line with what we have already been doing at the country/Embassy level.

We are very open to exploring with the Ministry of Foreign Affairs and Royal Netherlands Embassies opportunities to expand our knowledge brokering role in countries with (multiple) Dutch-funded SRHR partnerships. On the other hand, we are also open to discuss our presence and role in regions where Dutch SRHR needs or efforts are shifting or become increasingly difficult due to political or security situations.

In 2023, Share-Net International engaged in the consultations and development of the Dutch Global Health Hub. By signing the Pact we have shown our commitment to join efforts and willingness to build new partnerships. In 2024 we will be exploring more what we can contribute.

Last but not least, in line with our renewed strategy, we are excitedly following the developments around shaping the Feminist Foreign Policy. We are very motivated to join and support the Ministry of Foreign Affairs in this direction, learning together.

Fundraising

In previous years we have been more responsive to calls for proposal and started to also to strengthen our active fundraising efforts. To step up our business, a fundraising taskforce has been set-up with representatives from the different hubs. Active fundraising is encouraged around engagement with our Share-Net International secretariat shortlisted donors as well as the shortlisted donors in the hubs. The Share-Net International secretariat will take a leading and supporting role; encourage countries in their fundraising endeavours and collaboration ranging from facilitation of first (meetings) to proposal writing and budget development. Partnerships with private sector health companies have been identified as an additional opportunity to explore.

In terms of responsive fundraising, we will keep working alongside with the KIT Royal Tropical Institute SRHR team which has a well-established procedure starting with "scouting" opportunities.

Other sources of income have been discussed in 2023. For example, membership fees. The current membership fee structure which exists at Share Net-Netherlands and for Share-Net International members from non-hub countries needs to be evaluated. An aligned membership structure for all Share-Net International members, including country hub and non-country hub members, based on certain organisational characteristics (yearly turnover or staff numbers) was suggested by Share-Net International secretariat, to be more equitable, fair and supportive to sustainability. At this point country hubs don't feel that a membership fee structure fits their context. However alternative ways of income, for example selling our expertise, is being explored by some hubs. Membership fees and alternative means of income remain a conversation which is hard to accelerate but part of our sustainability plan. The tools offered by the Digital Platform could support analysis as well as our elaborated membership engagement plan could and bring this discussion forward.

Strategic partnership development

Strategic partners are organisations that can help us to be more visible, achieve greater results, put specific SRHR themes on the agenda, and/or with whom we can raise funds together. When we talk about partnership development, we mean developing and strengthening the relationships with these strategic partners. In practice, these are the bigger International Non-Governmental Organisations, colleague platforms or networks as well as multilateral organisations.

In 2024 we will keep strengthening some of our existing partnerships, such as with the Guttmacher Institute, International Planned Parenthood Federation, European Parliamentary Forum for sexual and reproductive rights, Equipop, Amplify Change and Asia Pacific Alliance for SRHR. For example, by coorganising sessions and events. We will likely collaborate again with World Health Organisation/IBP and Asia Pacific Alliance for SRHR in organising events around conferences.

Additionally, informed by the member analysis described above, we continue strengthening partnerships with specific members that can be seen as strategic partners, such as members working on access to safe abortion (Rights and Access of Women to Safe Abortion/RAWSA), sexual pleasure (The Pleasure Project) and build partnerships with LGBTIQ networks (ILGA) and organisations working on digital safety and security such as RNW media. We will also put additional efforts in strengthening the relationships with the Dutch SRHR Partnership Leads and consortia, following up on visits and more personal invitations to participate in our events actively. Equitable partnerships remain particularly important to Share-Net International. In our partnership development we will keep striving towards equitable partnerships.

Visits and Conferences

Despite all the difficulties during the COVID-pandemic we are able to say that we have visited all our country hubs and many of our country hub secretariat staff have been able to meet with each other as well. Acknowledging the impact of travelling on the environment, we also highly value the importance of physical meetings and interaction. In 2024, more than ever, we will make conscious decisions on when we need to meet in person and when this can be done remotely. We do not plan any big events in which we will bring different secretariat staff or members together. A face-to-face Celebration Conference would have been nice but would also hugely impact our environment, and at the same time we feel that is extremely challenging to facilitate equitable representation of our members. We do however want to physically attend and support some of the national and regional activities planned as part of our Knowledge Translation Fund. Also, two more lengthy trips are planned. Between Share-Net International and Share-Net Ethiopia to strengthen partnerships, and to support our active fundraising efforts and between Share-Net International and Share-Net Bangladesh to exchange experience and capacity around managing our Digital Platform.

In line with our strategy, putting rights first and following our conference choices in 2023, we plan to engage more in spaces where reproductive justice and sexual rights are being discussed and strengthen our presence in LGBTIQ communities.

In 2024 we will be closely following the events around International Conference on Population and Development +30 and we will be attending the Abortion and Reproductive Justice conference in Bangkok and plan to participate in ILGA's World Conference in Cape Town. Co-organising side events with strategic partners such as done with Asia Pacific Alliance for SRHR at International Conference of Family Planning and World Health Organization/IBP at Women Deliver is a success formula we would like to repeat.



In this chapter, we will elaborate on our plans for 2024 and how they contribute to the impact and outcomes that we attempt to reach with our activities. These outcomes are defined in our Theory of Change. Furthermore, the overall work of Share-Net in 2024 will be described and examples from the different hubs will be used to illustrate national efforts. In Annex 2, the specific country plans can be found.

DIGITAL NETWORK AND PLATFORM DEVELOPMENT

In 2024, Share-Net International will collaborate closely with our partners RedOrange, in Bangladesh, to develop and enhance the user experience, digital safety, privacy, and security of our websites and data-management to best protect our members (particularly those working on sensitive SRHR topics), redevelop the matchmaking feature on our digital platform, while strengthening data-connections between all Share-Net websites and infrastructure globally. This will be initiated with working-exchanges between Amsterdam and Dhaka in late 2023 and early 2024, with RedOrange's lead developer of Share-Net International's websites and Share-Net International's digital coordinator. This intends to strengthen the working relationship between Share-Net International and RedOrange, and strategically plan and future-proof Share-Net International's digital ways of working and infrastructure.

In 2024, multi-lingual website offerings will be developed, beginning with the launch of the French-Language version of Share-Net International's digital platform to cater to Share-Net International's French-speaking members and audience, which has been developed throughout 2023. As Share-Net International's network grows in an increasingly hostile online environment for SRHR information and potential security breaches, a large focus in 2024 will be ensuring digital safety and security of Share-Net International's members, and working on digital rights issues like online censorship, dis- and misinformation. Raising greater awareness of these issues will be initiated through launching a digital rights and SRHR international Community of Practice. Further, Share-Net International will work with digital security and privacy experts at DMCC to identify any potential weaknesses in our digital infrastructure, safeguard against data-leaks, and improve General Data Protection Regulation compliancy throughout the Share-Net network.

NETWORK DEVELOPMENT OUTCOMES

A network of SRHR Communities of Practice is operational, enabling members and strategic partners to connect, discuss and share, translate, and co-create SRHR knowledge

Communities of Practice serve as the primary mechanism for Share-Net to:

- encourage collaborative efforts in disseminating best practices and insights
- convert knowledge into accessible formats tailored to the intended audience
- collaboratively develop fresh knowledge resources

Simultaneously, Communities of Practice offer a platform for formal and informal connections among organisations or individuals from diverse sectors working on the same topics, uniting endeavours to enhance SRHR on both conventional and sensitive SRHR subjects. Ultimately, these communities play a vital role in engaging existing members and drawing in new participants to the platform.


In 2024, 49 Communities of Practice are planned to be active:

- 9 in Bangladesh (including one regional community of practice)
- 4 in Burkina Faso
- 6 in Burundi
- 4 in Colombia
- 4 in Ethiopia
- 11 in Jordan
- 7 in the Netherlands
- 4 International Communities of Practice with members from around the world

Most of the Communities of Practice have already been active in previous years or were set up in 2023. Others will be newly set up in 2023, such as the Community of Practice on SRHR and Disability in the Netherlands.

Communities of Practice fluctuate in numbers per year based upon the urgency and needs of members. Our Communities of Practice can become dormant if an issue is dealt with.

Share-Net International will continue facilitating International Communities of practice to foster cross-country learning and exchange.

The topics that those Communities of Practice are covering are 'Engaging men and boys', 'Sexual and Gender Based Violence' and 'SRHR of Adolescents and Youth'. In addition to the above mentioned, in 2024 Share-Net International will launch the International Community of Practice on Digital Rights and SRHR. As SRHR information increasingly moves online, the rise in dis- and miss-information, digital censorship, shadow banning, blocking, and algorithmic bias affects our abilities to share and access accurate SRHR information. This commonly affects multiple SRHR topics, including reproductive justice, abortion, gender-diversity, sexual pleasure, sexuality education, female bodies, and menstrual health information, while upholding patriarchal structures of oppression in digital information accessibility. This new international Community of Practice intends to uncover digital rights violations Share-Net members are facing. Bringing attention to digital rights issues in Low-Middle Income Countries and the global majority, opposed to only the North American and European context which much of the digital rights world focuses on.

Additionally, a joint Communities of Practice event will be organised in the first quarter of 2024. The event will focus on cross-country learning exchange and collaboration among the Communities of Practice. In the past, Communities of Practice members have expressed interest in learning from other SRHR professionals from other countries. As part of an effort to address this gap, the virtual event will be a nice mix of knowledge sharing (e.g. through presentations, panel discussions), knowledge exchange and promotion of knowledge use (e.g. workshops or consultation sessions) and networking. The organisation of the Communities of Practice event will be led by the Communities of Practice facilitators across all the Share-Net secretariat to ensure that the needs of the national Communities of Practice are catered to.

National, sustainable, and empowered Communities of Practice on SRHR are established and operational

In order to empower and activate Communities of Practice, the Share-Net hubs will collaboratively devise an annual action plan tailored to the specific needs and interests of the respective Community of Practice. This approach aims to instill a sense of ownership among the participants, providing them with the opportunity to take responsibility for the activities. Where feasible and pertinent, facilitators of the Communities of Practice will motivate them to seek funding independently or in partnership with the Share-Net secretariats and/or other stakeholders.

Communities of Practice possess the capacity to exert influence on both policy and program aspects of SRHR. Through collective efforts, members can unite to enhance practices and advocate for policy amendments. For instance, Share-Net Colombia intends to arrange periodic comprehensive meetings where members of Communities of Practice can exchange information about their ongoing initiatives. This initiative aims to bolster and sustain learning and collaboration among participants and Communities of Practice, while also identifying areas of knowledge deficiency and potential approaches to bridge those gaps.

KNOWLEDGE MANAGEMENT OUTCOMES

Policymakers, practitioners, and researchers have better access to information and knowledge on SRHR

Share-Net International's short-term goal is to enhance the availability of SRHR information and knowledge for policymakers, practitioners, and researchers.

This objective is achieved through a diverse range of initiatives, including:

- the distribution of newsletters and information via social media platforms at both national and global levels
- the coordination of specialized meetings and webinars
- the upkeep of Share-Net websites and the Digital Platform
- the facilitation of knowledge sharing among the Communities of Practice

Newsletters, social media, and websites

Regular email communications, newsletters, and social media activities promote relevant Share-Net activities, knowledge products, events, opportunities, and SRHR resources and news, but also provide a space to promote activities organised by Share-Net members in different countries.

Email communications and newsletters are shared in different intervals per country. In 2024, Share-Net will distribute a minimum of 56 newsletters and member mail outs:


- 12 by Share-Net Bangladesh
- 2 by Share-Net Burkina Faso
- 4 each by Share-Net Burundi, Ethiopia, and Jordan
- 6 by Share-Net Colombia.

Share-Net Netherlands will change their bi-weekly newsletters for regular mail outs to their members which will be sent out on a need basis (typically every 3-6 weeks). They will include a curated list of SRHR events, opportunities and updates.

Share-Net International will continue to distribute email communications on an as-and-when basis, typically every 4-6 weeks, with Share-Net news, opportunities, and SRHR updates. Tailored and specific mail outs are distributed to different member demographics (eg, updates on Comprehensive Sexuality Education developments sent to members working specifically on Comprehensive Sexuality Education). In 2024, Share-Net International will develop monthly thematic content throughout the year to coincide with relevant international days, highlighting digital SRHR resources and creating timely, relevant content for social media distribution. The language of newsletters and mail outs will differ per country, with most hubs sending newsletters in their own working language. Share-Net Jordan will publish a bilingual newsletter in Arabic and English to make it more accessible to all members.

All the hubs will continue to share Share-Net and SRHR information through social media and their websites. Social media campaigns will be used to attract more attention to relevant international days (for example, International Women's Day, Menstrual Health Day, International Safe Abortion Day, International Day Against Sexual Violence, Transgender Awareness Week, 16 days of action against Gender Based Violence).

In addition to the above, Share-Net Netherlands will launch their new website in early 2024 and continue using Mighty Network as a platform to foster intranetwork members communication and engagement.

Knowledge Products showcase webinar and knowledge product archive website

Throughout 2023, Share-Net International worked to promote knowledge products resulting from Share-Net grants. This was approached in a twofold manner; hosting the first annual 'knowledge product showcase' webinar offering Share-Net International's 2022 grantees a platform to present their SRHR knowledge products to the public, and through developing an SRHR knowledge product archive website, to showcase all the Knowledge Products developed via Share-Net International grants since 2014. The showcase featured 12 grantees, attracting more than 120 attendees over two days. The archive site will host more than 110 SRHR knowledge Products developed by Share-Net members and will officially launch in early 2024. Knowledge product and grantee promotional strategies are developed to offer Share-Net grantees wider exposure and promote their knowledge products through the Share-Net communication channels. Thematic events and round tables

Share-Net Burundi will also continue organising debates linked to international days such as International Women's Day, World Menstrual Hygiene Day, International Day for the Elimination of Sexual Violence in Conflict, among others. Experts on the topic will come together to present the latest insights on the topics and to facilitate a discussion amongst Share-Net Burundi members.

Share-Net Jordan will continue organising multiple round table discussions to present and discuss the policy brief and studies conducted in 2023. The topics for the round tables are:

- "Identification of Sexual and Reproductive Health Issues and Research Priorities based on Demographic and Family Health Survey 2023"
- "Caesarean deliveries in Jordan, causes and ways to reduce the prevalence of C-S deliveries"
- fact sheet on "The use of sexual aphrodisiacs in Jordan"
- "HIV/AIDS"
- "sexually transmissible infections"

Share-Net Netherlands will organise in-person thematic meetings for its members. One of the topics will be disability and SRHR and will focus on discussion around intersectionality of disability and SRHR, share challenges and best practices.

Finally, Share-Net Colombia will organise thematic webinars every three months where experts on different topics will share the latest information son certain topics such as mental health, sex work, and SRHR for people with a disability, amongst others.

Researchers address scientifically, politically, and practically relevant knowledge gaps in SRHR

By ensuring the accessibility of information and knowledge concerning SRHR, Share-Net members can utilize this valuable insight at an intermediate level to recognize and address the existing gaps in current SRHR research. Their active involvement in various events, including knowledge fairs, thematic meetings, roundtable discussions, and the annual student events, plays a crucial role in identifying these knowledge gaps and laying the groundwork for further research on SRHR.

Knowledge generation and research grants

As in previous years, in 2024 Share-Net International will continue awarding the knowledge activation grants. Members applied for knowledge generation grants at the end of 2023 and will start their implementation at the beginning of 2024. These grants will contribute to funding research and documentation of practices in SRHR, particularly in contexts where there are knowledge gaps about specific issues or certain population groups and communities.

In addition to the Knowledge activation grants, some of the hubs such as Share-Net Colombia and Share-Net Jordan. Share-Net Colombia will present the result of the grants and the knowledge products that were developed from the grants research in the Knowledge Fair that they will organise in the third quarter of the year. Share-Net Jordan have linked three knowledge generation grants with the regional Co-Creation Conference that they are organising as part of the Knowledge Translation Fund. The focus of this grants is how SRHR is integrated in the school curricula.

Grants for young researchers

Supporting the work of young people on SRHR is a key principle for Share-Net International. And we do this in diverse ways, and one of them is by sponsoring youth-led research projects. In 2024, Share-Net Bangladesh, Share-Net Burkina Faso and Share-Net Ethiopia will have specific grants for young people to conduct research. In Burkina Faso and in Ethiopia they partner with a national University to support the young people in conducting their research. Share-Net Burkina Faso will also support the young researcher in translating their research into a knowledge product that can be used by the wider network. These grants will promote and encourage focus on under researched SRHR topics and empower young people in their work.

Knowledge Translation Campaign

In 2024, Share-Net Burundi will conduct an exhaustive mapping of all data and knowledge available in Burundi over the past 10 years on SRHR. After compiling all that data, they will work towards translating the knowledge into products that can be accessed by different stakeholders. Some of the formats they envision for the knowledge products are visuals, infographics, videos, etc. Share-Net Burundi will use the Digital Platform and they will disseminate all those

Actual and effective learning is taking place in and between countries among policymakers, practitioners, and researchers

Learning within Share-Net occurs across multiple levels: on a national and regional scale among various Share-Net members, observed during thematic meetings, roundtable discussions, and similar events; at an international level among the staff of Share-Net hubs; and globally, fostering exchanges among members across different countries.

At International level: SRHR Partnerships - Linking and Learning

Since 2021, Share-Net Netherlands has been organising informal learning sessions between the consortium and implementing partners of the SRHR Partnerships. In 2024, we will continue this work and aim to organise 2-3 exchange sessions on important topics raised in the Mid-Term Reviews. Currently, we convene a reference group which has representatives from the different partnerships to guide and support the work that we do.

In 2024, we will continue to convene this group to ensure that the informal learning sessions are as relevant as possible and that they continue to stimulate cross-country learnings between the SRHR Partnerships.

At national, regional and international level: Grants for improved knowledge exchange and collaboration

Besides the knowledge generation grant, Share-Net members will have the opportunity in 2023 to apply for a translation or collaboration grant as part of the Activation Grants. The aim of the Activation Grants is to contribute to creating knowledge product(s) for improving policy and practice in SRHR. The collaboration grant does so by making it possible for a partnership of Share-Net members to formulate a sound proposal for strategic collaboration benefitting the SRHR movement. The translation grant allows one or more members to formulate a valuable proposal for a specific knowledge product. The application period for grants in 2024 is open at the time of writing, in October and November 2023 with the granted projects will be implemented in 2024. Like in previous years, we hope to award around 10 grantees, taking geographical and type of knowledge product into account. Additionally, Share-Net Netherlands will fund one extra application which was not successful in the Activation Grants.

At Regional level: Knowledge Translation Fund activities

In 2024, Share-Net Bangladesh, Colombia and Jordan will organise regional events linked to the Knowledge Translation Fund. Share-Net Jordan will bring together SRHR experts, practitioners, policymakers and researchers from Jordan, Qatar, Egypt, Tunisia to co-create together context-specific knowledge product to improve sexual and reproductive health and rights of in-school youth.

Share-Net Colombia will organise a regional Knowledge Fair on the topic of "SRHR for vulnerable populations". Relevant actors from the Latin America and the Caribbean region converge to share their own experience, recognizing good practices, discuss scalable solutions to specific problems identified or innovative ideas that emerge at the fair, as well as the promotion of knowledge products financed within the framework of this proposal. In addition, young researchers and students will be invited to present their academic thesis.

Finally Share-Net Bangladesh will conduct four online regional learning sessions and one online regional conference mixing the SHIRIM methodology with the Knowledge Fair. To guide the process, they will use the Comprehensive Sexuality Education Community of Practice which will become regional. During the learning sessions, members will translate knowledge and develop knowledge products to address the issues that the Community of Practice will identify. All knowledge products will be presented during the Knowledge Fair.

Knowledge is applied to evidence informed SRHR programmes, policies and practices

Share-Net International's overarching objective represents the ultimate aim that the network is striving for, with all other objectives serving as foundational elements that contribute to this final long-term goal. All activities undertaken by Share-Net, ranging from interactions with Communities of Practice, roundtable discussions, and newsletters to the implementation of activation grants, are geared towards fostering the utilisation of evidence-based knowledge to influence policies, programs, and practices related to SRHR. By establishing platforms that bring together and connect researchers, policymakers, and practitioners, we actively encourage interdisciplinary and cross-border knowledge sharing. Ultimately, this concerted effort will culminate in the practical application of knowledge to SRHR programs, policies, and practices.

Some of the hubs made specific plans to promote the use of evidence in SRHR programmes, policies, and practices.

Share-Net Colombia will continue working with Profamilia's Advocacy Office to advocate together, such as the Menstrual Health Law project, that is already being prepared and in which they have been collaborating. In addition, through SHIRIM 2022-23 they developed the knowledge product "Parches Diversos' ' which is an advocacy tool to improve LGBTQI+ Rights. Via using this tool, they aim to create awareness at community level and work towards behavioural changes.

Share-Net Netherlands aims to strengthen their collaboration with the Dutch SRHR lobby and advocacy group. They hope to be able to work in tandem with this group, providing knowledge management services to accompany them with their international advocacy work, especially with 2024 being the year of International Conference on Population and Development +30.

Share-Net Bangladesh aims to contribute to this long-term objective by targeting policymakers to participate in the Knowledge Fair where they will present the knowledge product developed via the Knowledge Translation Fund. In this way, policymakers will be able to use those products in their programmes and policies.

Lastly, Share-Net Burundi will be conducting two studies that will inform and guide the Mass Communication component of the SRHR Solutions programme funded by the Dutch Embassy in Burundi.



THEORY OF CHANGE REVISION

As recommended in our Mid Term Review and written in our Strategic Plan, Share-Net International initiated the revision of its Theory of Change at the end of 2023. This revision will continue and conclude in the first quarter of 2024. The primary objective of this review is to ensure the alignment of the Theory of Change with the goals, outcomes, and contexts of the Share-Net hubs. Furthermore, it will enable Share-Net International to reflect on and learn from the evidence and experiences thus far, which will inform adaptations, innovations, and enhancements in activity implementation and management. The revision will also integrate recommendations for potential changes and contextualization. Potential modifications to the Theory of Change will be finalised in 2024 and, in conjunction with the fundraising strategy, will guide proposal writing and acquisition.

Whereas our revised Theory of Change will be the foundation of our proposal we have already started dreaming with all the country hubs. Dream papers that have been prepared in 2023 will be consolidated into a shared Share-Net International dream. For the first time in our Share-Net International history, we are able to do this in a truly collaborative way and inspire each other.

ENDLINE AND SHIRIM EVALUATIONS

In all our work at Share-Net International we have a reflective and learning attitude. Meaning that evaluations are always built into our activities. Meetings and events are always looked back at, and points for improvement documented and re-looked at in preparation of new events. In 2023, at the time of writing this plan we are conducting a special evaluation of our SHIRIM learning trajectory. SHIRIM, being one of our biggest activities, has been reshaped into a Knowledge Translation Fund shifting more leadership to the countries. This evaluation will be finished early 2024 and recommendations will be used for our proposal development beyond 2024.

At the beginning of 2024, the Share-Net International secretariat will start preparing for our end evaluation to be delivered in 2025. We will organise this evaluation in a same way we organised our Mid-Term Evaluation. Starting by setting up a small working group which provides input on various moments in the process, firstly the Terms of Reference to recruit an external consultant.



For our 2024 annual plan we have budgeted 2.250.986 Euro. Entering the 5th year of implementation our budget defers less then 10% from our original 5-year planning (2.057.739 Euro). This shows that we have caught up with delays and related underspend caused by the Covid-19 pandemic in 2020 and 2021 and are on track.

Again, there is a slight increase (from 582.027 Euro to 615.000 Euro) in Budget line 1 (Share-Net International secretariat). This is mostly due to the audit that was not included at the time of developing the proposal.

Budget line 2 (knowledge management activities) was originally budgeted at 362.270 Euro and has been increased to 505.000 Euro. This is because the original SHIRIM was planned for 2023 but the localised approach to SHIRIM which resulted in the Knowledge Translation Fund requires expenses in both 2023 and 2024. A third Co-Creation Conference was originally planned for 2024 but has never been feasible as the remaining time within our contract would not allow for managing co-creation grants. We will reallocate this budget to online dissemination meetings and moments, celebrating and showcasing all the great work Share-Net International has been supporting.

Budget line 3 (knowledge hubs) remains approximately the same (990.000 versus 990.423 Euro originally planned). Individual country hub budgets will be decided based on expenditure in 2023 and more detailed country plans for 2024. Regional activities will be integrated in country budgets. It should be noted that the Knowledge Translation Fund means that in 2024 most countries have a significant additional budget to spend on Knowledge Translation activities often with a regional scope. This allows for a dedicated budget line for growing Digital Platform and increasing digital work in 2024.

As costs have increased over the past 4 years, we have increased the original budget for the end of project evaluation from 54.680 Euro to 75.000 Euro.

ANNEX 6. RISK ASSESSMENT

.....

This risk analysis highlights the potential risks of Share-Net International and the country hubs. They are classified as internal and external risks. These risks are categorised in the first column of the table. The second column gives a brief description of the respective risk and, if applicable, provides country-specific examples. The third column presents the probability that the risk may happen, according to three levels: **unlikely, moderate, and high**. The fourth column illustrates the severity the risk is expected to have in case it occurs. The severity is classified according to four levels: **minor** (limited reduction in outcomes if this occurs), **moderate** (higher impact, but still limited loss in outcomes if this occurs), **major** (outcomes are expected to be reduced if this occurs, but crucial outcomes are still likely) and **severe** (very significant reduction in outcomes when this occurs). The last column presents the actions Share-Net International takes or will take to prevent the risks from happening or mitigate the consequences the risk may have.

External Risks (Context & In-county situation)

Political

Bangladesh: Growing concerns regarding harassment (especially female journalists), disappearances, killing of journalists, impeding freedom of expression.

Terrorist attacks are more common since conservative movements gained more support (Hefazat). Especially LGBTQI+, key populations and people working on sensitive topics that are not in line with the thinking of these movements are at risk

Burkina Faso: Abortion and Comprehensive Sexuality Education are legally permitted under some conditions fixed by law but politically and socially sensitive. Open work on these may provoke backlash, but ministries will not obstruct or persecute organisations that work in these fields. LGBTIQ+ topics are not yet welcome in the country, talking openly about them is a risk. Recently, the country had experienced two coup d'état which have weakened the context of SRHR due to the change of the regime. Neighbouring countries such as Niger and Mali have also experienced coups d'é tat in recently. Political instability in the country and region can also influence the implementation of certain activities.

Burundi: In Burundi it is forbidden and illegal to discuss certain topics such as LGBTQI+ Rights. The Government strictly monitors and persecutes organisations who work on the topic. Colombia: It is possible that the economic performance of the country will worsen, continuing an elevated level of inflation in the costs of living. The 2022 election process resulted in a new, less conservative government, giving an opening to put SRHR in the agenda as a political topic. Colombia will continue to be a centrepiece of the geopolitical strategies of both the U.S. and China. Poor economic performance, the response to COVID-19, and the security situation are expected to harm the interests of incumbents and fuel political campaigns by opponents in 2024. Ethiopia: Until recently, foreign organisations

could not use concepts such as rights, this has been changing with the new leadership (PM Abiy Ahmed), but still needs attention. The US government is proposing bills to impose multilateral sanctions to addresses issues related to the conflict which may affect health and development programs in Ethiopia. Same sex relations and rights and Comprehensive Sexuality Education are politically and socially sensitive in Ethiopia.

Jordan: It is illegal to discuss certain sensitive topics such as LGBTQI+ rights. Latest news around political issues needs to be cross checked with country hub.

The Netherlands: New government might influence priorities in development cooperation and funds for SRHR and Gender in particular. Also, regarding the war in Ukraine (financial) priorities will shift.

Colombia: There are regions in Colombia that are more prone to natural disasters, especially droughts in the north of the country and less frequent flooding and landslides in more humid areas. In 2020 was marked by natural disasters that have had an impact on the functioning of the local economy in places such as San Andrés and Providencia, Chocó, and Bolívar (Central topics of discussion include deforestation, the energy transition, the Paris Agreement, and the Escazú Agreement). Ethiopia: Millions of people are faced with acute food insecurity and severe water shortages due to drought in arid and semi-arid parts of the country due to consecutive poor rainy seasons and livestock are emaciated or dead.
